Effective September 3, 2012, Identification Rules: Minimum standards for an acceptable ID will be a current government issued ID that includes a Photograph, Unique identification number, Birth date and Expiration date.

Texas State Comptroller-For Motor Vehicle Sales Tax Info www.window.state.tx.us

- SPV (Standard Presumptive Value): In 10/1/2006-Texas law changed how to calculate the motor vehicle tax on private-party purchases of used motor vehicles. For more information, call one of our offices or visit the State Comptroller's website.
- **Motor Vehicle Sales Tax Legislation-SB 267, Gift Tax**
 - Either the Recipient or Donor must file the *Affidavit of Motor Vehicle Gift Transfer* (Comptroller Form 14-317) **in person** at the Tax Assessor-Collector's Office. **Must** bring U.S. unexpired photo identification.
- Amendments to the Transportation Code provide for motor vehicle titles and registration to be transferred within 30 calendar days from the date of Texas purchase or being brought into this state.
- Also, Transportation Code 520.031 & 520.032, provide for an escalating delinquent penalty for failure to apply within 30 calendar days.

REGISTRATION PURPOSES ONLY (NO TITLE SURRENDERED TO TEXAS)

***IF VEHICLE IS LOCATED IN TEXAS AT TIME OF REGISTRATION THE FOLLOWING IS NEEDED:

1. REGISTRATION RECEIPT OR PROOF OF OWNERSHIP
2. APPLICATION FOR TEXAS CERTIFICATE OF TITLE (FORM130-U) SIGNED BY OWNER/AGENT.
3. ***PROVIDE PROOF OF CURRENT MINIMUM LIABILITY INSURANCE IN THEIR NAME.**
4. VI30-A FROM A TEXAS VEHICLE INSPECTION STATION.
5. APPLICATION FOR REGISTRATION PURPOSES ONLY (FORM VTR-272)
6. LIENHOLDER INFORMATION: LIENHOLDER'S NAME, MAILING ADDRESS AND MONTH/DAY AND YEAR THE LIEN BEGAN.

*NOTE: IF VEHICLE IS NOT LOCATED IN TEXAS AT TIME OF REGISTRATION ALL OF THE ABOVE IS NEEDED EXCEPT ITEM 4.
(SEE ADDITIONAL INSTRUCTIONS ON BACK OF FORM VTR-272)

OUT OF STATE TITLE SURRENDERED TO TEXAS

*** IF THE OUT OF STATE TITLE IS NOT IN YOUR NAME, THE TITLE MUST BE PROPERLY ASSIGNED TO THE NEW OWNER(S).

ALL APPLICABLE AREAS MUST BE PROPERLY FILLED OUT WITH NO ERRORS, ALTERATIONS OR WHITE OUT. Form 130-u must be signed by seller(s) and buyer(s). A signed Bill of Sale can be used in place of seller's signature on 130-U.

*** IF OUT OF STATE TITLE IS IN OWNER(S) NAME ALREADY, SURRENDER TITLE WITH:

1. FORM 130-U SIGNED BY OWNER(S) OF VEHICLE.
2. FORM VTR-272-B CERTIFICATION OF VEHICLE IDENTIFICATION NUMBER FOR VEHICLE LOCATED OUT OF STATE.

NOTE: STUDENTS LOCATED OUTSIDE OF THE STATE MAY USE THIS SELF-CERTIFICATION FORM IN CONJUNCTION WITH A VERIFICATION THAT THEY ARE A BONAFIDE STUDENT CURRENTLY ENROLLED IN AN ACCREDITED COLLEGE OR UNIVERSITY OUTSIDE THE STATE OF TEXAS.SUCH VERIFICATION MAY CONSIST OF A TUITION RECEIPT, ENROLLEMENT FORM, STUDENT IDENTIFICATION CARD, ETC. It is not necessary for the title application to be in the name of the student.

3. ***PROVIDE PROOF OF CURRENT MINIMUM LIABILITY INSURANCE IN THEIR NAME.**
